Agenda 1: Consideration of Minutes of Executive Committee Meeting held at

Prof. M B Shukla raised concern on non-availability of Action Taken Report

on specific matters mentioned in the minutes. This was discussed and the house

resolved to approve the minutes subject to the action taken report being made

available. The minutes along with the action taken report will be circulated for

approval.

While discussing the issue of renewal of registration for IAA, based on

discussions held last year, members raised concern on the data required to be

submitted for renewal. Dr. Anil Kumar stated that 3 years past records would be

sufficient. Resolved to have a Committee to pursue the matter of renewal of

Agenda 2: Consideration of Accounts of the Association. TDS and Accounts

The Treasurer presented the accounts and the same were approved.

Agenda 3: Finalization of Auditors for 2019-20

Resolved to have M/s Nemani & Associates, Flat No. 108, SR Complex, Opp. CCMB, HABSIGUDA, Hyderabad as auditors for the year 2020-21.

Agenda 4: Maintenance of Accounts by Branches and activities of branches

41 out of the 53 branches had submitted their accounts and the same were consolidated. The treasurer reported that some of the branches had closed their accounts and a few are yet to submit. The branch activities reported by different branches in the form of seminars, workshops, FDPs publications were uploaded on the website as given by the branches. There was a suggestion that branch -wise remittance need to be disclosed in the financial statements with number of members added during the year. The house resolved to approve the same. The website of IAA is currently maintained by Prof. Sanjay Bhayani, free of cost, there was a suggestion to have the website maintained professionally by experts for which payment has to be made . the House resolved to approve the same

Agenda 5: Indian Journal of Accounting – reporting on status and future improvements for recognized status

The Chief Editor Prof. S S Modi reported on timely dispatch of journal to all the members. There was a request for disclosing the names of reviewers and need for proper language correction in the articles to be published. The house did not have unanimity on disclosure of reviewers list, however language correction through experts could be considered for which payments has to be made in case expenses are to be incurred. Resolved to approve the Language Correction proposal. There was a report that some members were not receiving the journal as address correction was not executed. Prof. Sanjay Bhayani stated that address corrections were instantaneously made when reported. Some issues prevailed because of non-

reporting of address change. Efforts taken to obtain CARE recognition were

discussed.

Agenda 6: NATS reporting on status and betterment of standards,

organizational matters for NATS

The coordinator for NATS Dr. Shurveer S Bhanawat reported on the status of

National Accounting Talent Search Examination which is being conducted in more

than 50 centers. The coordinator sought support from executive members in

enhancing participation in the examination. Prof. K Erasi reported on an agency that

would help in online conduct of the examination using mobile applications. He

stated that the representative was asked to make a presentation before the EC and as

the person did not turn up the matter need not be considered.

Agenda 7: Role and functions of EC Members

This item was not taken up for discussion for want of clarity.

Agenda 9: Venue of the 43rd All India Accounting Conference.

Two proposals were received with resolutions from the respective IAA branches.

1. Osmania University, Hyderabad

2. Rani Channamma University, Belagavi, Karnataka

The proposers made their presentations and defended their claims. As there was no consensus on the venue, the matter was put to vote. Based on the voting results, Osmania University, Hyderabad was chosen for the 43rd All India Accounting Conference With Prof V Appa Rao as the Conference Secretary

Agenda 10: Co-option and election of members to Executive Committee

Members raised questions on the constitutional provisions regarding Co-option. The matter was discussed in detail and it was resolved that three members from each zone could be co-opted by members of the Committee empowered for elections comprising of the President, Senior Vice President, Junior Vice President, General Secretary and the Conference Secretary. Resolved to approve the same.

Agenda 11: Any other item with the permission of chair.

- 1. Prof. K Achalapathy spoke on the proposal from American Accounting Association to associate with Indian Accounting Association on areas of common interest and holding of mutually beneficial conferences and seminars. The matter was discussed and the house resolved that this could be possible only through an MOU with the American Accounting Association. Prof. K V Achalapathi to be authorised for examining the possibilities for an MOU with the Association.
- 2. Prof. K R Sharma spoke on the need for developing Accounting as a distinct and unique discipline which was a specialised body of knowledge. This would be possible through association with professional institutions in Accounting. Need for developing the discipline with new courses and potential for research

need to be examined in the areas of Financial Accounting, Taxation, Cost and Management Accounting.

Resolved to have a committee to consider the above matter with the following constitution.

3. Members raised concern over having research scholars as Executive Committee Members. There was a proposal on the possibility of making it mandatory to attend three out of the past five conferences as an eligibility criterion to become an EC member. Branch secretaries meeting had also suggested inclusion of branch secretaries in the Executive Committee. Prof. Sulochana raised the issue of having one post of office bearers reserved for women. To examine the above and other related matters which would require change in the Constitution. Resolved to constitute a committee to examine the above matters and report on the same.

IAA Foundation Day (March 15) Celebrations were commenced on 15.03.2020 as an annual event to be celebrated thought out the country in all branches.

4. COMMENTS ON IASB EXPOSURE DRAFT:

The association first time ventured into sending comments on Exposure Draft (ED/2019/7) on General Presentation and Disclosures issued by International Accounting Standards Board.

5. NATIONAL WEBINAR AND SERIES OF ONLINE EVENTS:

IAA took the challenge of the pandemic situation in strides and rather converted it in opportunities. IAA head office made a head start and organised two days national webinar on a very relevant topic of "Accounting Education in Virtual Environment" (April 29-30, 2020). More than 200 faculty members, research scholars and post-graduate students from India and abroad participated in the webinar. One of the unique features of the event was that eight Past Presidents of IAA delivered key-note addresses during the Webinar.

This marked the beginning of good number of academic events in form of webinars, lecture series, workshops, FDPs etc. organised by IAA branches all over the country in the following months. The topics included Impact of Pandemic on Indian Economy, Teaching and Learning in Online Plat- form, GST, IFRS, Accounting Standards, Interpretation of Financial Statements, Use of SPSS in Research, Academic Writings, Econometrics and others. Some of these seminars have been International and have been organized in association with other professional Bodies and colleges also.

We have enhanced our membership to cross 6700, We have by now expanded to 56 branches with 3 new branches added this year Warangal, Kozhikode and Coimbatore, we could enhance our NATS examination centres to over 50 and reach a land mark of Rs 1.20 crore in our corpus fund. What is even more delighting is the fact that we could activate our branches though proper submission of Accounts and reporting of branch activities.

Our practice of interacting with branch secretaries as part of the All India Accounting conference and uploading Branch activities on the Website have been fruitful. The upkeep of the website and reporting system proved to be beneficial.

We could successfully conduct the NATS examination in 2020 and the current year's examination work is in progress. Thanks to Prof. Shurveer S Bhanawat, the founder Coordinator Prof. G Soral and their team. Due to pandemic situation NATS committee has taken the decision to conduct examination scheduled on Feb 7, 2021 by online mode. I hope, with cooperation of all of you, this will increase number of participants in upcoming NATS examination.

I sincerely congratulate all the Branches for their activities and involvement in IAA. I further request all branches to strengthen their activities and examine how they can academically enrich the Accounting profession.

I am happy to share that due to efforts of our Treasurer Prof. Arindam Gupta and his team 43 branches of IAA have submitted their audited accounts.
