Minutes of the Meeting of the Executive Committee of the Indian Accounting Association held on 29<sup>th</sup> October, 2022 at 8:30 p.m. at the Venue of 44<sup>th</sup> All India Accounting Conference at Gwalior under the Chairmanship of Prof. M.L. Vadera, President IAA.

In the meeting, 49 members were present (List Attached as Appendix I)

At the outset, Prof. Sanjay Bhayani, General Secretary extended a hearty welcome to all present at the meeting. Prof. M. L. Vadera, President, welcomed all members while making his opening remarks.

**Agenda 1: Consideration of minutes of the meeting of EC held on 18th December, 2021.** The Minutes of the Meeting of the Executive Committee of IAA held on 18<sup>th</sup> December, 2021 were approved.

Agenda 2: Consideration of the Annual Report of the Association for 2021-22. The Annual Report – 2021-22 of the Association was approved.

**Agenda 3: Consideration of reports of various sub-committees for 2021-22.** Annual Reports of the following sub-committees were presented by respective chairmen in the meeting:

1. Branch Activities Supervision Committee (Chairman - Prof. Jas Raj Bohra): A formal meeting of the committee could not be held, though the number of active branches increased.

2. Foreign Collaboration Committee (Chairman - Prof K V Achalapathi): Presented how IAA can increase foreign collaboration.

3. Professional Bodies Liaison Committee (Prof. Usha Kiran on behalf of Prof K Eresi): MOU with the Institute of Cost Accountants of India was signed. The same with the Institute of Company Secretaries of India was at an advanced stage of discussion.

4. NATS Promotion Committee (Chairman - Prof. Shurveer S. Bhanawat):

The last examination in February 2022 was conducted successfully on online mode and results were declared in time. Preparations for the upcoming examination are in full swing. Resolved to conduct NATS at the international level without any additional expenses on it.

5. IAA E-Content Development Committee (Chairman - Prof. Ranjan K Bal):

E-Contents in the form of books, articles, videos, NATS question papers etc. were uploaded on the website.

Committee has demanded to reimburse the expenses related to the development of econtent with the following budget expenditure of Rs. 50,000 and it is approved.

6. IAA Renewal of Registration Committee (Chairman - Prof. M. B. Shukla & Convener - Prof. Sanjay Bhayani):

Resolved to get the renewal of registration done at the earliest. Further resolved to engage a consultant for the purpose and reimburse any expenses incurred for that (payment of renewal registration fee, the penalty for renewal of registration, Consultant fee, Miscellaneous expenses and T.A. and D.A. of Committee members etc.). Further resolved to add Prof. Arindam Gupta – Treasurer as a member of the Committee. It was also resolved to authorise the committee to take any decision related to the renewal of IAA registration.

7. Model Curriculum Committee (Chairman - Prof. K. R. Sharma):

An extensive curriculum for graduation, post-graduation, add-on courses, job-oriented courses, and certificate and diploma programs in the accounting discipline were prepared and uploaded on the website. A revised draft of the Model Curriculum has been prepared by the committee after a long series of meetings and the same has been widely circulated for comments as an exposure draft.

Committee has proposed to conduct a "Survey of Stakeholders Expectations Regarding Accounting Curriculum" and the following budget of expenditure has been proposed to conduct this survey.
