Minutes of the Meeting of the Executive Committee of the Indian Accounting Association held on 24th November, 2023 at 8:30 a.m. at the Venue of 46th All India Accounting Conference at Kolkata under the Chairmanship of Prof. V. Appa Rao, President, IAA.

In the meeting 65 members were present (List Attached as Appendix I)

At the outset, Prof. Sanjay Bhayani, General Secretary extended a hearty welcome to all the members present at the meeting. Prof. V. Appa Rao, President, IAA welcomed all the members while making his opening remarks.

Agenda 1: Consideration of minutes of the meeting of Online EC held on 13th November, 2024.

The Minutes of the Meeting of the Online Executive Committee of IAA held on 13th November, 2024 were approved.

Agenda 2: Consideration of the Annual Report of the Association for 2023-24.

The Annual Report – 2023-24 of the Association was approved.

Agenda 3: Consideration of reports of various sub-committees for 2023-24.

Annual Reports of the following sub-committees were presented by respective chairmen in the meeting:

- 1. Model Curriculum Committee (Chairman Prof. K. R. Sharma) in absence of Chairman, Prof. K. Eresi has presented the report in detail. He mentioned that the committee had 36 marathon meetings over past four years and came up with many editions of model curriculum besides initiating Accathon, IAA Certification Programme, IAA START Forum, IAA Research Helpline and IAA National Quiz.
- 2. IAA E-Content Development Committee (Chairman Prof. Ranjan K Bal): E-Contents in the form of books, articles, videos, NATS question papers etc. were developed and uploaded on the website.
- 3. Foreign Collaboration Committee (Chairman Prof K V Achalapathi):

He presented details of collaboration with American Accounting Association, particularly the concessional membership offered to Life Members of IAA for \$75, for retired members \$30 per year in place of their normal fee of \$345.

The above committee reports were approved by the members.

Agenda 4: Consideration of Report of Chief Editor of Indian Journal of Accounting.

Prof. Nimmi Dev, Chief Editor IJA has presented report of IJA which was approved. It is further resolved to obtain cross reference and DOI for journal and expenses incurred for it is to be approved. It is also decided to apply for listing of IJA in UGC Care, Scopus, Web of Science and ABDC.

Agenda 5: Consideration of Accounts of the Association for the FY 2023-24.

The Treasurer has presented the accounts and the same were approved. From next financial year onwards, all IAA activities audited accounts should be attached with consolidated accounts of IAA. It was resolved that due to non-payment of 42nd IAA Conference amount due from Prof. Jas Raj Bohra,

Conference Secretary to issue notice by Treasurer for payment of due amount, number of delegates registered and submission of audited accounts of the conference. Further, it is to be noted that an amount of Rs. 31,000/- was received from Prof. Jas Raj Bohra for settlement of due amount.

It is further resolved that the Treasurer will issue a demand notice of due amount from the 46th IAA Conference Secretary onwards based on the number of registered delegates, who have paid delegate fees to attend the conference, as to be produced by the Conference Secretary to him at the end of the Conference.

Agenda 6. Appointment of Auditors for the FY 2023-24 and fixation of auditor's remuneration.

Resolved to reappoint CA D Das & Kamaluddin, "Moona Plaza", 62, Lenin Sarani, 3rd Floor, Kolkata – 700 013 as auditors and Tax Consultant (Income Tax and TDS) for the financial year 2022-23. It is further resolved that President, General Secretary and Treasurer are authorised to fix the remuneration for the auditor.

- 3. Get Bank Account opened in its capacity as AOP.
