Application for the award should contain two parts:

(ii) Recent passport size photograph and brief profile of applicant
(iv) Declaration about originality of research work

- **One set of scan pdf copy of five research papers with display of author name.**
- **One set of scan pdf copy of five research papers no indication of author name (disguise name of author) should be there anywhere inside in the research papers.**

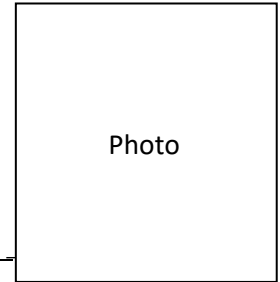
